

## Contract for SWIM SNAPS Underwater Photographic Services

Swim Snaps Studios LLC (SWIM SNAPS) and LOVE SWIMMING agree to the following terms:

- A SWIM SNAPS underwater photo Session (Session) will take place at LOVE SWIMMING in New Orleans, LA on January 14, 2018 for the duration of five hours divided into two sessions with an hour break in between.
- The fee for this Session is \$2,000.00 which covers the photographer's time in the water, editing time, and travel.
- LOVE SWIMMING will be responsible for the scheduling and billing of participants. SWIM SNAPS will endeavor to provide at least five underwater images for each participant from which to choose. However, the final number of images available will depend on the ability and cooperation of the participants and cannot be guaranteed.
- Up to four participants can be scheduled in each half-hour. The participants will be in the water at the same time and will be rotated throughout the half-hour Session. *For swimmers 3 and under, an adult guardian will be required to be in the water during the session. Alternatively, an additional LOVE SWIMMING employee can replace the adult guardian requirement.*
- Because safety is of the utmost importance at all times, two LOVE SWIMMING instructors will be required in the pool throughout the Session specifically to assist with the SWIM SNAPS photographer. Another LOVE SWIMMING employee will be required to assist with check-in and necessary paperwork.
- The images will be uploaded to [www.SWIMSNAPS.com](http://www.SWIMSNAPS.com) within approximately three weeks for parents to choose their print images. One 5" x 7" print will be available free of charge to each participant **WITH** the order of additional prints.
- SWIM SNAPS images are copyrighted and may not be sold or reproduced without the express written consent of Swim Snaps Studio LLC. During the registration process, parents will be asked to sign an optional photo waiver so that LOVE SWIMMING and SWIM SNAPS can use the photos produced in this Session for promotional purposes.
- LOVE SWIMMING will receive a USB drive or link to Dropbox with the photos from this photo Session. The digital files provided will be those which families have purchased from the session. These images may be used for promotion of LOVE SWIMMING only. LOVE SWIMMING is prohibited from and hereby agrees not to sell or distribute the digital photos from the Session to any third party including the participants themselves.
- Access to the LOVE SWIMMING pool one half hour in advance of the Session will be required to facilitate set up.
- **Optimal water clarity is imperative for quality underwater photos and is the responsibility of LOVE SWIMMING. SWIM SNAPS cannot be responsible for sub-standard photos arising from poor water clarity.**

A deposit of \$1,000 is due and payable upon booking. Checks should be made payable to **SWIM SNAPS, 4141 LYBYER AVE, MIAMI, FL 33133**. The remaining \$1,000 is due when the Session photos are delivered to LOVE SWIMMING for distribution.
